# News from the President....

Hi Everyone,

I bet your semester started out as fast-paced as mine. This year, not only does CCL have a new president, but there are also five first-time board members. They will be representing their regions and I want thank each of them for stepping up to this responsibility. At the CCL Board retreat in July, the Board developed its 2006-2008 workplan. I encourage each of you to take a look at it on page 4.

Last week, I had a meeting with the new Vice Chancellor for Academic Affairs, Carole Bogue-Feinour. Gregg Atkins and Dan Crump, the chair of the Chancellor's Office Library and Learning Resources Advisory Committee, joined us. We discussed the importance of reviving the Advisory Committee, which has not met in 18 months (and then only by phone!). I was encouraged by Carole's interest in library issues, including the Advisory Committee and the Annual Data Survey, and look forward to building upon this relationship.

Dan will be calling a meeting of the Advisory Committee in the near future. At that meeting, the Committee will be reviewing the work of a CCL taskforce that has proposed changes to the Annual Data Survey in ways we think will make it more useful. We hope that the Advisory Committee will agree to the changes and that the Annual Survey will have the new elements when it is sent out this year.

As president, I attend the California Community Colleges Chief Instructional Officers' Executive Board meetings. At the last meeting, the CIOs briefly mentioned a computer lab committee that is having discussions on the use of the labs and supplemental instruction. The chair is John Spevac from Merced College. The CIOs also discussed the new English and Math graduation requirements that go into effect in Fall 2009. ## Support Services for Distant Learners

At the 2006 **Online Teaching Conference** held at San Diego City College Johanna Bowen, Cabrillo College Library Director co-presented with Francine Van Meter, Cabrillo Distance Education Director, at an afternoon breakout session entitled "**Cabrillo College Online Library and Student Resources.**"

There is ample research to prove that strong support services have a beneficial impact on the academic success and retention of traditional on-campus students. As yet there is little research on the impact of strong support services on distance learners.

What is the difference between a distance-learning student and students at a distance? Institutions providing full programs via distance education need to provide a full range of services at times and in ways that are convenient for these students. These services include library resources, admissions and registration, enrollment advising, academic advising, financial aid, career counseling, textbook ordering, technical support/assistance, and disability assistance.

## Database Usage Statistics

Changes are underway in the world of database usage statistics. Until recently, database vendors often used different criteria for collecting usage statistics, making it difficult to compare apples to apples. To help with this issue, we now have COUNTER (Counting Online Usage of Networked Electronic Resources). COUNTER is a not-for-profit organization formed through the participation of libraries, publishers, vendors, and information providers to develop and provide an international set of standards and protocols governing the recording and exchange of online usage data. To begin with, COUNTER will focus on journals and databases, but Ebooks and other types of content will be covered in subsequent releases of the COUNTER Code of Practice. While this standard is fairly new, many of the vendors have already started making COUNTER reports available. Look for them in the administrative module of your online databases.

While COUNTER helps librarians with accurate comparison of database usage, it is still extremely time-consuming to compile the data from each database provider. In light of this challenge, the National Information Standards Organization (NISO) is developing standards for moving COUNTER usage statistics into a digital repository. This initiative, SUSHI (Standardized Usage Statistics Harvesting Initiative), includes participants from libraries, ILS vendors and online content providers collaborating to develop a model that includes an automated request and response for usage statistics. Future products using SUSHI be able to automatically collect usage data from multiple databases—making our lives easier!
