CCC BASIC AGENDA UPDATE: LIBRARY/LRCs LEFT OUT AGAIN

Have you been carefully working your way through the 92-93 Basic Agenda? Got it all marked up? But just can't find any reference to library/lrc programs and services? That's because there isn't one, even though the Basic Agenda serves to comprehensively describe the plans and priorities for all of the programs within the California Community Colleges.

What to do? An update and suggestion from Lois Marriott, CCL Executive Director:

"Our voice CAN make a difference!

"For many years we have been complaining that the word "Library" has never appeared in the BoG's Basic Agenda. Last year we thought Carolyn Norman had succeeded in convincing the Chancellor's Office staff to incorporate appropriate language into the 1991 revision, but when the final document was printed, guess what???

"However, next year should be different; it seems that the 1993 revisions to the *Basic Agenda* will include "library" or at least "learning resources," according to a memo dated 9/22/92 from the Chancellor's Office.

"Last summer I sent a letter to John Parkhurst, BOG President (with copies to Board members Julia Wu, Yvonne Gallegos-Bodle and Larry Toy) explaining why CCL believes it is vital that the library's educational role and importance be officially recognized in their pivotal document. I was notified last month by Julia Wu and Yvonne Bodle that they agreed with us, and that the BoG had discussed this "oversight" at their September meeting and had determined that such reference should be incorporated into the next revision!

"Judy Walters, Vice Chancellor of Policy Analysis at the Chancellor's Office, further verified this in her memo of 9/22/92, stating that although our request "was too late for inclusion in the 1992 revisions of the Basic Agenda, we will make certain to include this request when the Board makes revisions to the next Basic Agenda."

"It is reassuring that, once again, our collective voice has been effective in making a change. CCL will continue to advocate for improvement of our libraries and learning resources programs, and to educate and proselytize our administrators. For example, we have invited Julia Wu, BoG Board member, to be our guest at our annual meeting this year in Long Beach in November.

"Come and make YOUR voice heard!"

REVISIONS TO TITLE 5 GET BoG OK; NEW LIBRARIAN HIRES COUNT IN 75/25 RATIO

The CCC Board of Governers has adopted a State Chancellor's Office recommendation which revises Title 5 regulations so that new faculty librarian hirings now count for a college with regard to the 75/25 ratio required by AB 1725. However, the change is only in effect for two years, barring extension or revision). This removes a critical barrier for many library/lrc units seeking to add faculty librarians. The BoG acted at its September meeting. (See California Code of Regulations, Title 5, Div. 6, Chap. 4, Subch. 3, Sec. 533310 or Item 13 of the BoG AGENDA for Sept. 10, 1992.)

Board action was originally scheduled for the May meeting, but representatives of faculty counselors raised objections about the exclusion of counselors from the proposed revisions. The BoG delayed adoption while discussions were held with various interested parties and while a review was carried through the consultation process.

The revisions were altered to include a 2-year sunset provision (but did not include counselors), with the understanding that the Chancellor's Office would convene a "task force to develop more appropriate methods of ensuring that districts commit sufficient resources for librarians and counselors."

The task force has been assembled by Joe Newmyer, Vice Chancellor for Fiscal Policy. Faculty librarians are represented by Rosalie Amer (Cosumnes River College, Los Rios CCD). The primary focus of the group is upon changing the 50% Law into a "60% Law" which also includes librarians, counselors, and classified library/Irc staff who have responsibilities similar to instructional aides. No timeline for presenting a recommendation (which would require changing the Ed Code) has been developed.

93-94 STATE CCC BUDGET PROPOSES RESTORATION OF **INSTRUCT'NL EQUIPMENT \$**

It's Ba-a-a-ck! Maybe.

As part of the budget request presented by the Chancellor's Office and approved by the Board of Governors at its Sept. 92 meeting, Governor Wilson will be asked to include \$35 million for restoration of the "instructional Equipment and Library Resources Fund to its 1987-88 level."


The CCC budget proposal next goes to the Dept. of Finance for a two-month review. In January 1993, the Governor sends his proposed 93-94 State Budget to the Legislature for discussion and review.

The language of the agenda item seems to suggest, however, that a new statewide telecommunication system which meets education, business, and community needs" for the CCC system would also be paid for using some of these same funds. Stay tuned

At least 11 colleges got the go-ahead for proposed Library/LRC building projects in this year's final prioritized list. Approximately \$340 million is expected to be available, although the uncertain fiscal state of the State could substantially reduce that amount during the course of the year and drop projects off the list. This year's projects are:

PRESIDENT'S PERSPECTIVE . . LELAND RUSSELL, PRESIDENT Dear Colleagues.

This first issue of CCL Outlook for the 92/93 academic year reaches you at a time when California and its fine system of higher education faces severe financial problems. Economic survival for our community colleges has been put to the test in ways not even imagined in the aftermath of Prop. 13. The role of community colleges has been challenged, not very subtly, by the imposition of differential funding for holders of BA degrees; the increased fees for all other students may cause a significant downturn in enrollment this next spring. Many cuts have been made in campus staffing, money is generally tight, and budgets for our libraries and learning resources programs have suffered similar cutbacks. It's generally a rather dark time for all of us and the students we serve.

But there's some excitement and hope as well. Many of you are in various stages of planning for or constructing new buildings — the ultimate professional challenge for some and often a once-in-a-lifetime opportunity. A number of you are in the process of installing OPAC's and new CD-ROM products. There's a new focus on quality on many campuses — TQI and TQM are the current buzz acronyms — and economic necessity has forced us all to find new and often better ways to meet "customer" needs. Even the prospect of multitype networking with other California libraries in

ways only dreamed about in the past holds promise of improved service and greater cost effectiveness. Yes, the times are difficult, but let's try to keep things in perspective. We're resourceful professionals, and we'll weather this crisis as we have others.

I'm delighted to report that, as of Oct. 22nd, membership dues have been received from 76 colleges. In a number of instances, the dues have come in the form of personal checks from the deans/directors themselves — testimony, I believe, to the continuing faith in CCL as an effective voice in support of California's community college libraries. The financial support received from our member colleges permits CCL to print and distribute this newsletter, to publish our directory with its details about our respective institutions, to provide reports and compilations of statistical data to our members, and to monitor and/or lobby on issues of significance to our members.

The Executive Committee held its first meeting of the year in San Diego on August 27th. Gregg Atkins and John McGinnis were elected to serve as Northern and Southern Region Vice-Presidents, respectively. Gregg agreed to edit the *CCL Outlook* another year, and Will Baty agreed to undertake the updating of the directory. Plans were made for the Annual Meeting, and dates were set for regional meetings in the spring, and for Executive Committee meetings for the balance of the year.

We also appointed Lois Marriott to serve as CCL Executive Director, an act that made me delirious with joy. Lois brings to this post a (cont'd on page 2)
