



The site opens with this statement: "California community colleges have a legal responsibility to provide equal access to video resources for students, faculty and staff who are deaf or hard of hearing. This is often most easily accomplished through closed captioning of video resources."

The site offers information on topics ranging from the definition of terms to background information on captioning, to providers of captioning software and hardware, to vendors who provide captioning services. The site also has examples of video captioning permission letters.

One College's Decoder Story

Over the last few years, many community colleges have invested in multimedia classrooms. As a part of this, many televisions were removed and digital video/computer projectors were installed. As the Merced College LRC began looking at closed captioning issues, we realized that our wonderful (and expensive) projectors did not have the ability to display closed captioning. The director of the Audio-Visual Department, Gilbert Arguelles, did some research and purchased three closed caption decoders. He and his staff tested and evaluated these decoders, and chose the UNIVERSAL V-7310 (produced by Security Systems Inc) as the decoder to be used with classroom and cart-mounted digital projectors. The decoders work with our older Panasonic projectors and with our newer Texas Instruments U21130 Plus projectors. The AV staff indicates the decoders are easy to install. Faculty members report that the decoders are easy to engage. We paid around \$150 for each projector.

One College's Permission Letter

As many of us try to work out copyright issues, we can turn to the experience and expertise of others. There are sample letters on the High Tech center web site listed above. What follows is the Cerro Coso Community college letter reprinted with the permission of Dr. Dennis VanderWerff.

Cerro Coso Community College requests authorization to modify the audiovisual material to include captioning descriptive narration for the purpose of ensuring access for students with disabilities within the instructional setting for education purposes.

Cerro Coso Community College presently owns copies of the material. The material is used in conjunction with classroom instruction for educational

purposes. In addition, the material may be loaned to other public California Community Colleges upon request through interlibrary loan agreements. This audiovisual material will be used until such time as the material is removed from the Cerro Coso Community College collection.

Your signature on this document confirms that permission has been authorized. Authorization will be clearly placed on the audiovisual material. Written authorizations will be kept on file in the Alternative Media Center.

SUBSCRIPTION HANDLING FEE FOR NON-CCL MEMBERS BEGINNING WITH SPRING 2002 ORDERS AND RENEWALS

As you are aware, one of the real successes of the Council of Chief Librarians has been its cooperative purchase program for online subscriptions. Working with Evan Reader of the California State University system and Ray Giles of the Community College League of California, our program has provided community college libraries with the ability to purchase online subscriptions at consortium prices. The program has grown and grown. This year the League and CCL hired a Cooperative Purchase program Manager to oversee this incredible effort.

In the past, all community college libraries participated at the same cost whether or not they were CCL members. Beginning with the Spring 2002 orders and renewals, non-CCL members will be charged a once-per-calendar year processing fee of \$100 when they submit their subscriptions.
