### CCL PRESIDENT'S MESSAGE:

To: Librarian Colleagues

From: Johanna Bowen

Is everyone as busy as I am with the push to go from slow-paced Summer school to fullspeed-ahead Fall 2004 semester? We can relish our roles as librarians and deliver first class library services to the world's largest higher education system – the California Community Colleges. I am hoping that the slightly improved economy will allow us to focus on our teaching and learning imperatives instead of waiting with bated breath for the mid-year correction right after the election (yes, I can be cynical)

There are two new separate issues for us to attend to:

Every one of us should be paying very close attention to the *California Performance Review*'s suggestion which proposes combining the California Community Colleges Chancellor's Office, California Postsecondary Education Commission, California Student Aid Commission and Bureau for Private and Postsecondary and Vocational Education - under the administration of the Office of the Secretary for Education. I may be putting it simplistically but if we lose our independent Board of Governors and report to the Secretary for Education with the K12 districts we will suffer in the long run. Take a look at the adequacy, state wide, of library services for high-school students.

We should all be asking why the *Performance Review* did not suggest steps in the direction of the State University of New York which has a vertically aligned system of Higher Education with the Community Colleges, the four year colleges, and the research universities under one HIGHER EDUCATION umbrella.

In addition, we should all be concerned about the merger into one fund of *Instructional Equipment and Library Materials* with *Scheduled Maintenance* funding. Do you know how the money will be divided up on your individual campuses?

Library issues have never been limited to our immediate professional milieu. Public policy decisions that will have an effect on the 2.8 million students will affect our libraries as well.

One of our strengths as a professional group is our willingness to talk and to learn together. We have two singular opportunities to gather in the next few months.

# T T I P SURVIVES THE BUDGET BATTLE

In August, an e-mail went out from the CCCCO to all TTIP Administrative and Technical contacts informing them that the *Library Resources and Automation TTIP Funds* would be advanced beginning in the August allocation to the colleges. The original dollar figure was noted as \$36,364, but a correction memo later went

out to correct the amount to \$36,697. This adjustment will be made at P1 in February. The \$36,697 reflects the \$4M divided by 109 colleges recognized by the BOG.

### **NOTES FROM THE BOARD RETREAT JULY 2004**

• *Agency Review* recommendation about data collection; role of System Office

CCL needs to immediately respond to the *System Agency* Review, which recommends that the System Office relinquish all responsibility for data collection about CCC libraries. We oppose this recommendation. The System Office should retain the authority to collect data and report on status of libraries, and should disseminate and collect the response. The "library association" can assist with data analysis for the report CANNOT collect the data. System Office should extend the MIS services to solicit the data. Can cite the minutes from the Advisory Committee: The system should collect the data; collection of the data is important. The report does not reflect the agreement reached at the Advisory council's meeting in January.

CCL (Johanna) and LLRPAC (Dan) agreed to take responsibility for writing a formal objection. They will copy this letter to FACCC and to the Academic Senate asking for their support. They will copy the letter to the Listservs asking for endorsement.

Loritta, Dan, Mary Ann & Jim will examine IPEDS and NCES library surveys to determine if either could replace current survey tool. They will report at January meeting.

### • CCL – EAR Update, provided by Cheryl Stewart

Cheryl Stewart, who is the new chair, reports that EAR meetings are scheduled for Fall already. CCC-Confer has worked really well as a vehicle for the committee to get its work accomplished An article is planned for the October *Outlook;* it will be a review of Online Reference services. Cheryl Stewart and Johanna Bowen both noted that CCL-EAR has evolved to deal with whatever is a high priority for libraries (e.g., ebooks). The committee's meeting schedule will be openly distributed, and non-members will be invited to attend and observe. Cheryl will publicize the meetings to the EAR-INFO and to the Board. Johanna proposed that, since the EAR group has 5 new members and a new director of the CCL - CCLeague consortium, it would benefit from having 3 face-to-face meetings this next year. Board agreed and budget will be adjusted to cover the costs.

### • Membership Report, provided by Gregg Atkins

CCL ended the year with 94 member institutions (budget assumption was 80) out of 110 possible. Those institutions which did not join are: Barstow, Cañada, Chaffey, Coll of Alameda, Coll of Marin, Compton, Cosumnes River, Crafton Hills, Folsom Lake, L.A. Trade-Tech, Merritt, San Diego City, Santiago Canyon, Solano, Ventura, West Hills, West L.A.
