At the Annual meeting, there was time to discuss planning topics for future initiatives. The following topics were mentioned:

Library Deans and Directors Annual Meeting

Sacramento, CA March 2, 2007

Below are brief notes from the meeting.

Patrick Perry, Vice Chancellor, Technology, Research and Information Systems, provided an annual report and update on TTIP funds. The goal of TTIP, governed through TTAC (Telecommunications and Technology Advisory Committee), was to provide a common technology infrastructure throughout the California Community College system. This provides a base level of technology capability at each college and is accomplished by using purchasing power based on economies of scale for technology commodities. In 1996-97, TTIP funds were \$9,300,000. In 2000-01, funds were \$44,400,000. This year, 2006-07, TTIP was funded at \$26,197,000. Over the last year, TTAC has developed a set of programs that together make up a "TECH III" plan. None of the plans made it into the Governor's Budget in January. There is hope that some will be included in the May revise of the budget. The Governor's staff has shown interest in the following programs:

- 1. Connectivity to the official offsite centers.
- 2. To automate the curriculum tracking/approval process both at the System Office and locally.
- 3. Create a centralized GIS function to geocode district boundaries and marry it to the MIS system to create a geospatial data warehouse.
- 4. Create the infrastructure to have free wireless hotspots on all campuses, one in the library and one in a student center.
- 5. Create redundant network circuits to the campuses.

Other projects of interest to libraries include:

- 1. \$2M for funding of vocational databases (Add to the \$4M in TTIP funding).
- Develop open source student portals that could create a single access point of entry for all student services (eliminate need for standalone E-proxy programs and vendor password systems to access library databases)

Carole Bogue-Feinour, Vice Chancellor, Academic Affairs, spoke about the Basic Skills Initiative and implications for libraries. The new English and Math graduation requirement begin with students enrolling Fall of 2009. A literature review due out the end of March shows many student services, including library services, will be required for student success. Librarians need to get involved in the Basic Skills Initiative planning on their local campuses.

Scott Lay, CEO & President, Community College League of California was our keynote speaker, and talked about the climate change on campuses. Some of his points:

- Only 70% of high school students graduate from high school on time
- Only 35% of ninth graders who finish high school on time go on to college
- 50% of adults do attend college at sometime, often later in life
- Known fact that the later one attends college, the less likely one is to graduate
- Growth of college students will continue to be immigrants
- 2/3 of all jobs require college-level skills
- Only 10% of community college students arrive ready for college level courses
- 63% of college students attend a community college, yet financial aid is much less (\$155 for community college student; Cal State students get 4-5 times that amount).

LeBaron Woodyard, Dean, Instructional Programs & Services, Academic Affairs provided updates from his area of the Chancellor's Office. Updates included:

- Title 5 is undergoing major reorganization and revisions. Tentative timeline: 1st reading, May 2007 and August implementation.
- Program and Course Approval Handbook being revised, with changes for non-credit courses.
- Distance Education—working on validating Data Mart information. Faculty and student surveys have been revised and are available online.

Dan Crump representing the Systems Office Library and Learning Resources Advisory Committee announced that the revised Annual Survey should be out to libraries in a month.

Sarah Raley, Electronic Resources Consortium Director, Community College League of California made several announcements, including the posting of the Spring program offerings are posted on the web, and a number of mergers in the publishing field. The CCL-EAR committee is currently working on a comparison of health databases and the report should be finalized in May.

Mary Ann Laun, Assistant Dean, Pasadena City College, reported on her sabbatical. Her goal was to step back in order to look forward and to find new ways to serve students in the digital arena. She is focusing on three areas: 1) catching up on new technologies by attending conferences, workshops and online classes; 2) Reviewing Pasadena City College's need to preserve resources digitally; and 3) review the needs of California community colleges for preserving digital resources. She encouraged everyone to find an hour a week to explore a new technology.

In addition to all of the information presented by these speakers, the attendees had the opportunity to discuss various library issues, both in group breakout sessions and informally during the day.

CCL-EAR Committee Update from Tim Karas

Northern California Vendor Fair

The vendor fair held on February 23, 2007 in Walnut Creek was a tremendous success. Over 35 librarians from 26 different colleges attended the vendor fair. The vendor fair included presentations from Xrefer, Alexander Street Press, Gale's Literature products, and a vendor panel discussion (Gale, EBSCO and Proquest) regarding health databases. I want to thank everyone who attended the vendor fair and encourage others to attend future CCL-EAR vendor fairs.

Committee Reviews

The CCL-EAR Committee is made up of representatives from each of the 10 regions in the state who bring forward suggestions of databases to review from libraries in their region. Committee members discuss the merits of the database suggestions and select databases for analysis based on their value to community college libraries. The committee reviews the databases to educate the field about their use, functionality and content. The committee maintains a database of their reviews at http://www.cclibraries.org/index.html. The committee also works with Sarah Raley, consortium director, and with vendors to improve the offerings made available through the Community College Library Consortium.

How the Consortium works:

The consortium director, Sarah Raley, negotiates group purchases with the database vendors to secure the lowest possible pricing that enables the community colleges to realize savings of thousands of dollars each year. Sarah identifies new database products using recommendations from the field, the CCL-EAR recommendations and other sources.

There are some vendors who will not give discounts to consortia (e.g. JSTOR, ARTstor, College Source) and in those cases, individual campus subscriptions may be the least expensive option. However, there have been instances where a vendor has attempted to circumvent the process by negotiating "side deals" with individual campuses that may be undercutting the success of the consortium pricing system. The success of the consortium is dependent on the support of its members. The CCL-EAR Committee would like to encourage all members who deal with vendors to give them Sarah's contact information. In most cases, she can negotiate substantial savings on behalf of the consortium.
