Hi,

As I write this letter, there is some hope on the issue of purchasing a state-wide license for a database for 2011-2012. At last week's Telecommunications and Technology Advisory Committee (TTAC) meeting, Vice Chancellor Patrick Perry and I presented a proposal to carve out about \$1M from the 2011-2012 \$15.5M TTIP technology budget to fund one general journal database for the CCC. The Chancellor's Office Library and Learning Resources Committee also met last week and approved of the statewide purchase concept.

Vice Chancellor Perry and I provided evidence (using information provided by Consortium Director Sarah Raley) that we could get a discount of up to 50% for an order of a single statewide general journal database instead of having each college continue to purchase a general journal database as they have in the past. The colleges are in fact collectively spending \$2m where one statewide purchase of a general journal database would cost only \$1m.

These are hard times. To free up \$1M from an already extremely limited budget in the way we are proposing is perhaps a difficult sell to make. To strengthen the proposal, the colleges would have to accept that the saving from the statewide database purchase comes with a price. The trade would be that the TTIP technology budget would no longer fully fund the existing second (backup) network line into the colleges. The colleges would have to pick up some of the costs of the second line. A college could choose to use the savings differential for their share of the second line or for some other purpose (another database perhaps?).

Now comes the second part of the proposal which is even more challenging for the colleges and for us as librarians. To get greater savings, we would need to add another shared, statewide database using college funds to expand our savings. There are enough issues with accepting a single general journal database that is "best" for all of us. Can we as librarians in a system, yes, in a system, use our own money to purchase a second database using the same economies of scale? Can we see the advantages of a second shared statewide database enough to both endorse the purchase and to lobby our colleges to get everyone on board? The evidence is there, the savings are there, can we do it?

At the March Deans and Directors meeting, VC Perry and I will be there to discuss the proposal in further detail. VC Perry will have to lobby for the proposal in various arenas. The proposal is not a "done deal". There are many ways that the statewide purchase effort can fail. If it does get approved and funded, there will be time to decide on the final criteria to use to pick the database. I bet that the database would not be online until January 2012 with perhaps a 18 to 24 month subscription period.

On a completely different topic, I have served for 5 years as your CCL President. If we had been under our old, non-incorporated bylaws, I would have been termed out last year. Under the new incorporated bylaws, my term does not end until June 2012. However, I have notified the board that I will resign as President as of June 30th, 2011. The Board will be holding a recruitment drive and a board vote for a new president in March. I hope each of you will consider nominating yourself to be the CCL President. REPORT: CALIFORNIA COMMUNITY COLLEGE STUDENT LIBRARY AND TECHNOLOGY SURVEY

Timothy Karas Dean of Instruction; Liberal Studies & Language Arts (Mission)

The Council of Chief Librarians of California Community Colleges (CCL) in collaboration with an independent Researcher designed a survey intended to clarify and provide understanding on how California community college students use technology and libraries. Five community colleges (East Los Angeles, Mendocino, Merced, Mission, and Santa Barbara) are administering the survey in a pilot project. Preliminary results of the pilot will be shared at the Statewide Library Deans and Directors meeting in March 2011.

Description: Develop and pilot a longitudinal research strategy for the Council of Chief Librarians of California Community Colleges that will provide actionable insight into the information and learning technology profiles of campus student populations.

Goals:

- Understand local users.
- Support learning needs.
- Track technology trends.
- Prioritize and refine services.
- Foster cohesion.

The Advisory Committee met on February 16 at the Chancellor's Office. It has been several years since we have had the opportunity to have an in-person meeting and allowed us to go over some important foundational work. We reviewed the purpose, membership and functions of the Committee along with the mission and goals. We will have a conference-call meeting in late March to finalize these discussions. LeBaron reported on the progress of the Annual Data Survey---almost a 100% response rate! He is working on the last few responders. It is hoped that the data will be available to us on the Chancellor's Office website in the near future. In addition, this data (and the ensuing analysis) will be used in a presentation by Chancellor's Office staff to the Board of Governors at their July meeting on the condition of CCC libraries. The entire committee will be working with LeBaron on this project.

CCL-EAR Vendor Day held in Ontario

Forty librarians attended the January 28th vendor day sponsored by the CCL-EAR sponsored in Ontario. The theme for the day was new interfaces. ProQuest presented their new user interface followed by EBSCO with the Netlibrary interface. Credo presented the Topic Pages add-on to their General Reference Collections and Gale discussed the Opposing Viewpoints in Context interface changes from last fall.

ProQuest has rolled out the new user interface for students. Colleges have the option when to change to the new interface but the company hopes that all customers will migrate by the end of June 2011. The new interface allows users to search across all PQ databases. It includes a My Research function and the ability to create durable URL's to link to articles. We have been assigned a central point of contact for any technical issues (Frank Monaco). He can be reached directly at 800-889-3358; extension is 2386. His email address is frank.monaco@proquest.com

EBSCO will release the new Netlibrary interface in the summer of 2011. The Netlibrary name will be dropped in favor of their new name – EBSCO eBooks. Content will be cross-searchable with other EBSCO databases and users will be able to print up to 60 pages in a session. The existing MARC records will remain stable and will automatically redirect.

Credo has introduced an optional Topic Pages subscription as an add-on to a subscription to their general reference services. Topic pages link to specific subjects and are available on the web. Links to the resources are limited by a subscription. To see an example of a topic page in ecology, go to http://www.credoreference.com/topic/ecology

Gale demonstrated *Opposing Viewpoints in Context*. The company has completed studies that show students like the new interface. The new interface features audio streams, topic pages and links to citation tools.

On a different note:

ALA mid-winter was held in San Diego on January 7-10. At the meeting of "Hot Topics for Community Colleges" held on Saturday, Jan. 8, the CCL-EAR product reviews were on the agenda. Librarians from other states utilize these reviews as they are evaluating products. Glorian Sipman (CCL-EAR chair) discussed the criteria for these reviews and the other librarians were encouraged to also post comments at the website. NetLibrary Superseded Editions List

From time to time, librarians inquire about weeding the NetLibrary shared collections. This is problematic for the reasons stated in the eBook selection policy http://www.cclibraries.org/providers/ebooks/EbookCollectionDevelopmentPolicyFinal.pdf

De-selection Criteria:

At the present time there is no de-selection policy for the shared collection. Deselection is complicated by two factors:

- 1) Collections have been sold to libraries with the guarantee that they would have access in perpetuity.
- 2) Not all libraries have purchased all collections offered. If a decision were made to deselect a title in a particular collection with a newer edition from a subsequent collection, a library that had only purchased the earlier collection would not have access to either edition.

Given these factors, the CCL-EAR Committee recommends that libraries wishing to delete titles remove the MARC records from their OPACs. The Committee is open to creating a list of superseded titles based on recommendations from CCC librarians. Librarians wishing to contribute recommendations are encouraged to contact the e-Book Selection Team Chair.

The committee has begun to compile the list of superseded titles as described above. Please send your recommendations to the eBook selection team chair, Carolyn Singh (CSingh@ShastaCollege.edu).

<u>Perceptions of Libraries, 2010: Context and Community</u> http://www.oclc.org/reports/2010perceptions.htm

OCLC's newest membership report, Perceptions of Libraries, 2010, a sequel to the 2005 Perceptions of Libraries and Information Resources, is now available. The new report provides updated information and new insights into information consumers and their online habits, preferences, and perceptions. Particular attention was paid to how the current economic downturn has affected the information-seeking behaviors and how those changes are reflected in the use and perception of libraries.

This OCLC membership report explores:

- Technological and economic shifts since 2005
- •Lifestyle changes Americans have made during the recession, including increased use of the library and other online resources
- •How a negative change to employment status impacts use and perceptions of the library
- •Perceptions of libraries and information resources based on life stage The report is based on U.S. data from an online survey conducted by Harris Interactive on behalf of OCLC. OCLC analyzed and summarized the results in order to produce this report.

E-Book Citations:

On February 6, 2011 *The Chronicle of Higher Education* published "<u>E-Books' Varied Formats Make Citations a Mess for Scholars.</u>" In the online content of an eBook, Kindle, Nook, iPads and other devices were putting the same text on random different pages (or provide no pagination at all.) There really were no fixed pages within an electronic representation of a text.

[It would have been nice if the article had acknowledged the fact that librarians in higher education bear the brunt of the burden of explaining and teaching citation formats to students **and** scholars.]

AccessMyLibraryCollege gives you unlimited, 24/7 access to your college library's Gale online resources. Your students must have an .edu email extension. A cookie is placed on your phone. (iPhone)

Alexander Street Press: Listen to an audio track or watch a video on your mobile phone Wherever you see the "send to mobile" icon, you are able to obtain a "shortlink" to enable playback on your mobile device. (iPhone and Android)

EBSCO: You must create a mobile profile for your students and add databases to it. http://support.epnet.com/knowledge_base/detail.php?id=4431 If not authenticating through the college's proxy, may need a username & password. (Android, BlackBerry, Dell Axim, iPhone, Palm 750)

These trends and challenges are a reflection of the impact of technology that is occurring in almost every aspect of our lives. They are indicative of the changing nature of the way we communicate, access information, connect with peers and colleagues, learn, and even socialize.(page 4)

Key Trends:

- The abundance of resources and relationships made easily accessible via the Internet is increasingly challenging us to revisit our roles as educators in sense-making, coaching, and credentialing.
- People expect to be able to work, learn, and study whenever and wherever they want.
- The world of work is increasingly collaborative, giving rise to reflection about the way student projects are structured.
- The technologies we use are increasingly cloud-based, and our notions of IT support are decentralized.

Technologies to watch:

The six technologies to watch are presented within adoption timelines that indicate likely time frames for their entrance into mainstream use for teaching, learning or creative inquiry.

- Within the next 12 months: electronic books and mobile devices.
- Within two to three years: augmented reality and game-based learning
- Within four to five years: gesture-based computing and learning analytics.

Critical Challenges:

- 1. Digital media literacy continues its rise in importance as a key skill in every discipline and profession..
- 2. Appropriate metrics of evaluation lag behind the emergence of new scholarly forms of authoring, publishing, and researching.
- 3. Economic pressures and new models of education are presenting unprecedented competition to traditional models of the university.
- 4. Keeping pace with the rapid proliferation of information, software tools, and devices is challenging for students and teachers alike.

To complement the report, the New Media Consortium this year designed the <u>Horizon</u> <u>Project Navigator</u>, a social-media site to offer access to the materials experts looked at in preparing the report and share information related to the identified technology trends.


